How you finance your degree is a big part of your decision-making process. All admitted applicants are automatically considered for merit-based program-funded assistantships; however, funding is not guaranteed. We recommend that you plan with the full program cost in mind. In addition to these start-up expenses, potential expenses to consider are moving expenses, rent deposit and monthly rent payments, books/laptop, utilities (electricity, gas, and water), etc.

Typical Graduate Assistantships only cover tuition waivers in the amount of \$5,734/semester in-state and \$14,828/semester out-of-state. Students must cover the balance. The Financial Aid Office will only process need-based funding for United States Citizens. Additionally, university-wide merit-based scholarships may be obtained through the Graduate School.
